







  - Make County government structure more effective.


- Action should be taken to increase climate resilience within the County


# Chenango County Vision 2050 Plan ACTION SURVEY RESULTS





- The County needs to prepare and align its policies to support the resumption of natural gas development, and to support natural gas supply to manufacturing sites. The "climate" agenda against fossil fuels is itself not sustainable, as it is based on unsound claims about warming and about weather impact. Also, large-scale solar and wind energy development is counter to the higher priority of preservation of our rural/agricultural/scenic character. - Lower taxes so people want to live and invest here. Get rid of the rural solar farms and windmills-look up how damaging they actually are. I am planning to leave this county & never would've moved here if I'd realized how bad that is.
- Need to have manufacturing that supports agriculture, need to balance that with push on tourism, need to work with all localities and neighboring counties to promote area as a whole

- I feel our largest concern right now is to figure out how to handle the drug traffic that we have in this county. The second largest concern is to figure out on how to help the homeless population with basic needs for living.
- With how few entries are in the individual lists, I want to emphasize that something being ranked last out of 3, doesn't mean I believe it is unimportant.
- I have a master's degree and no where to work unless I have a long commute. The homeless population and drug addiction rate makes neighborhoods unsafe. Children have no where to entertain themselves- so they fall into bad habits. Renovate and upkeep the parks, more school sports (hockey, lacrosse,) to become competitive with other districts. More opportunity for work besides trades. Incentive or lower rent for businesses to open shop and STAY open. There are too many storefronts that are abandoned and not well maintained. Look to other cities (Syracuse, Binghamton,) for help catching up. Our kids and families deserve better than the bare minimum.
- We need to continue to revitalize unused spaces. And beautify the community.
- Sustainable Living has different definitions for different residents
- "1st- Early childhood intervention. When you know better you do better. This goes hand in hand with youth programs.
- 2nd-Jobs, jobs, jobs. Financial stability DOES equal happiness. Happiness=hope and hope lowers drug and alcohol abuse.
- 3rd- Affordable housing and the elimination of slum lords in Norwich. These property owners don't live here, don't check on their buildings or tenants and rake in millions over charging HUD. Also wouldn't hurt to find some money to repair the homes in Chenango county for the MIDDLE class owners.

There's nothing where I live and would have to travel 30 mins or more to have access to an indoor place to shoot hoops or have access to an indoor gym. It makes no sense that schools have fitness centers that the public who assists in paying to support the school cannot access. Why is there no community centers like the Y outside of Norwich?
- Emergency Services, Provide funding to support full time county wide ems system. Offer livable wages and continuing education so it will attract quality providers to stay and work in our county.

- We need to address the homelessness created by drugs and enabling government programs.

Industry that converts raw materials create jobs for non college grads that are careers with good benefits and perks. Retail, restaurants, entertainment all need many industrial complexes to ensure a steady clientele and trade to support the jobs within these sectors.

- "Parks: the number of parks seems sufficient but all need better amenities, equipment and maintenance. We need an inpatient facility for mental health and substance use treatment and comprehensive aftercare for those returning from inpatient services"
- Renovate the vacant and deteriorating "Victory" building into a homeless/rehabilitation center. A location where workshops, alcohol/drug abuse counseling can take place.
- Community members should get jobs to help themselves and not just expect to have all things provided for them. Children, however, must be supported with our best efforts to help them to be safe, well-educated and fed.
- We need to empower people, and teach them the skills on how to provide for themselves and their families, while being less dependent on government
- Too much money is allocated to social programs when there are no evaluation tools or measurements to justify spending. Each social program should have itemization of all expenses and third party evaluation of how successfully a program meets its mission, goals and objectives. If it isn't working, stop funding it and work toward a more effective use of funds. Every social program should have an annual audit and evaluation of services.
- Chobani can help access to nutritional resources by paying their fair share of taxes to Columbus (instead of wiping them out in court fees) and also by paying every full-time employee no less than \$75,000/year. PLEASE FOR THE LOVE OF CHENANGO have higher expectations for billion-dollar companies and CEOs. Can you imagine how that kind of change alone would impact our local economy????

- All of these options are beneficial.
- If you are looking out as far as 2050 you should be considering the consolidation of school districts from the standpoint of superintendents and administration. The funding gained by this consolidation could be used to strengthen programs aimed at improving student outcome and future opportunity. In addition, with the exodus of people from upstate NY the volunteer fire departments are no longer viable in many communities. A plan for 2050 MUST include the consolidation or county-level oversight of a county-wide response network (fire and medical).

- None of these are important as compared the economic viability of the county. These are all political hot button topics. None of these truly improve a communities ability for citizens to take care of themselves. They all are aimed towards government subsidies and coddling of people. You cannot balance a budget without subsidies with programs like these. They are not self sustaining. I would rather see more money spent on bringing viable companies into the area that employ people with honest jobs that allow families to thrive. Creating giveaway programs and all sorts of government agencies and organizations to prop people up is the exact opposite of what you should be doing. Do any of you in the county government know how a large business really works? It is not by baby sitting the employees and families.

- Housing is a significant problem. The cost of living is too high. Not only for those receiving public assistance, but those who are outside that level of need. Oftentimes, those above the threshold also struggle with childcare, housing, and regular household maintenance. A lot of times, even those who are "middle class" find themselves having to prioritize needs because after everything, they barely make it pay check to pay check. There's such a focus on those in "the system" that increasing taxes, cost of living, childcare, amongst other needs has them at more of a disadvantage

- Green energy is great but using land where houses could be built or could be used for agricultural or manufacturing sites isn't the best use of the land. Consider building small parking garages in Norwich so that some of the larger lots can be repurposed for development
- Our area seniors need viable transportation options as MLT and A&D are unreliable, leave them stranded and this impacts their healthcare needs. I see this all the time in my professional life and I feel its a travesty. I left multiple messages at The Office of the Aging as a professional and they never bothered to return a single call I made.
- Support famers with bio-digester installations. Solar is not efficient enough yet, don't
  waste taxpayer money on its use/installation until the efficiency is > 70%. Also, remember
  whatever "sustainable" energy source is determined to be installed/used there needs to be
  a long-term look at what the plan is to do with the waste generated from them (i.e. old
  solar panels, windmill blades). Along with the reality that most of the recourses needed to
  build the "sustainable" energy source is less sustainable then using oil to begin with. Lets
  be smart about picking and choosing sustainable energy sources.
- Plant trees as oppose to investing in toxic solar power and alternative energy technologies which are far more devastating to the environment than traditional gas/oil/coal. Forbid solar farms due to the fact that they are forever destructive to the land and water, kill off wild life and provide a small life span while giving a small amount of energy.
- "Fast speed internet development strategy should be multi-pronged. As the technology of satellite broadband enters the market it should be included (at least at a pilot level deployment). Also, with""IoT"" becoming more and more common place and necessary to manage data/information, networks that support these devices for various industries (especially outdoor activities like agriculture and forestry where connectivity is remote/non-

existent).

- For infrastructure: we should encourage more micro-type PV solar installations for individual home owners to gain more energy independence (via nyseg credits). The industrial scale deployments are fine but have very few financial beneficiaries while smaller scale deployments democratizes and provides more autonomy for solar energy"
- If climate change is in fact an "existential threat" then the state should be willing to utilize state land (or allow the counties to do so) for renewable energy projects instead of offering unrealistic rewards to poor, rural communities who agree to these projects only because they think they will reap great financial rewards and jobs (which never materialize). I am absolutely disgusted by the way the county has handled the High Bridge wind project and I think the entire process, from the state-level down, is grossly negligent and rife with nepotism. If the county is going to be transparent about alternative energy opportunities, then the county should drive the state to do a realistic survey of sites which are BEST SUITED for these projects because those sites will provide the highest energy production in the long run, not because they will be cheapest for the industry.
- Technological literacy is often considered a need for older populations, however is quite necessary for the younger groups as well. Many school-based technology programs are either no longer in use or involve only part of the very basics, even during my time learning in the 2000s and early 2010s. I believe this would be important to keep in mind while developing the aforementioned programming.

- Commerce Chenango needs an attitude change. Along the lines of: forward, supportive, promotional.
- What is "Micron"??? Keep in mind 1/2 the farms still do not have adequate internet or cell phone service to keep current or to do "text messaging"!!!
- A good first step would be to get rid of the abandoned houses... nothing says a 'lively downtown' and ' bring your business to Norwich ' quite like a bunch of squatters cutting heroin in a home code enforcement hasn't visited in years.
- "Let's not limit our industries to manufacturing and agribusiness. Financial services, engineering, healthcare and education are vital too."
- Our job market is stunted and pays pennies to the dollar of nearby cities. I could move an hour away and make \$5 more an hour doing the same work. Why? We cannot retain quality professionals in our area when we cannot compete with nearby salary. This impacts education, medical resources, and so on. We should be working to expand local amenities-the bowling ally is such a waste. There needs to be more to draw people in and keep them. Everything buttons up here early on weekends. Families are traveling elsewhere to find things to do. Nothing to do unless you want to go to a bar. Young professionals find it an unfulfilling and underpaid area and leave.
- Ask local businesses what they need for success, sustainability and expansion. Lower taxes for businesses. Become a self-governed community by breaking away from state mandates as stated in the NYS constitution.
- I wonder if local small businesses would need this much support if it was regular practice in our culture that giant, billion-dollar companies paid their employees higher wages?
- Strategy 2 Provide digital and physical material to demonstrate how to spend a weekend/day in Chenango County: We could gameify or provide some other incentive, such as digital badges to show someone has completed all recommended activities, or other badges/keepsakes to represent completing certain individual or batches of activities.
- For tourism: Rail Trail, Rail Trail, Rail Trail!!! Also for tourism: Have more of a regular social media presence with upcoming events in our local towns (ie festivals, concerts) with a ""press release"" every month. Also, after attending 4 towns forward and Bainbridge CoC meetings: leaders would love training in social media. A county effort to do this for our various CoC's could really help them!
- If you want Chenango County to be a "destination" you need to do something about the fact that much of it looks like a third-world country (and I have been to many of them in 29 years in the military) with vacant homes and farms, formerly beautiful old barns collapsing in on themselves, homeless drug abusers on the street corners etc. If you want people to come here there must be evidence of PRIDE in the community. People here have no hope and it shows. Relating to that, I am curious why you would focus on Micron (which is 90 minutes away) instead of looking at industry in the immediate area (Chenango and Delaware counties) such as Chobani, GE Aerospace, Amphenol, McDowell-Walker, Unalam, Golden Artists, Alvogen or even Mirabito and Preferred Mutual. We have industry in the local area. Why not partner with them to expand opportunities and bring a source of pride back to Chenango County? This is a BLUE COLLAR region. The development efforts need to acknowledge and serve this population.

- We should add the CleanTech Battery development, in addition to Micron, to the third initiative above.
- I am sure you do not need to be reminded that the education in Chenango County beyond high school is lacking. Whilst I believe that the opportunities offered by BOCES, SUNY Morrisville, and Cornell's extension in the area are great and should be encouraged to grow further, the net needs to be wider. BOCES has a variety of programs however, at least from my experience growing up here, is widely considered just where they send students who cannot make it in regular high school, while in reality that is only a side project essentially. Morrisville offers programs in agriculture and human resources almost exclusively in their Chenango County campus, and Cornell appears to focus on agriculture as well. As an agriculture-heavy area this is awesome, however as an individual who does not want to be involved in either of these fields, my only choice was to continue my education outside of Chenango County, and upon returning I found my opportunities lacking, something that I will attribute, not wholly but in most part, to the lack of these other skills in the area. I believe that more nearby educational institutions should be invited to participate nearby, even if they do not open buildings directly inside Chenango County and offer reliable pipelines to reach the skills that companies that will be encouraged to move here will want to see from their employees. I would point to how Wolfspeed in Utica has fostered their partnership with the nearby schools as an example of how this can build that path.



# Framework Overview Organizing Ideas & Elements

**Goal** – A general statement of <u>a future condition</u> towards which actions are aimed addressing a particular area or issue facing the community that impacts the vision. Goals should not dramatically change over time but rather be consistent throughout the planning horizon.

**Strategy** – A statement of <u>a measurable activity</u> to be accomplished in pursuit of the goal; it refers to some specific aspiration which is attainable. Think in terms of actions such as "increase", "develop", "continue", or "preserve."

Action - A <u>specific proposal</u> to do something that relates directly to accomplishing a strategy; it can take the form of a plan, project, or program. The lifespan of an action item can vary from one to 10 years depending on the item.

In this plan, there are generally two types of actions:

- Direct County Actions: Actions that may be taken directly by Chenango County to help achieve the goals of a given focus area.
- Community Actions: Potential actions that can be taken by municipalities, businesses, organizations, and residents which the County may support as a coordinator, connector, and/or informational resource. The County may also assist with efforts to secure funding, where necessary and appropriate.

# NEEDS IN THIS FOCUS AREA
